- Randy asked what does culture of disability mean?
  - o Winnie talked about how experience of people with disabilities can shape them. People with disabilities also are part of many different cultures.
  - o Liliane suggested culture of disability course should be available to parents.
- How can we offer supports and partnerships with regional and state agencies?
  - Winnie said part of goal 1 and part of partnership with
    Department of Disability Aging and Independent Living
- Need more materials and media representation for people with developmental disabilities.
- Arline recommended teachers in schools need training to better support. Shared examples of punishment and disciplining students

- o Jesse reviewed the priorities in the annual summary.
- o Michael said an important part of accessibility is making sure there is enough information for everyone.
- Jesse shared that providing full information and using different media is our plan.

Question for the CAC: What information do you think is most important for them to be successful?

- o Get to know CAC. Who we are and what we believe.
- Valerie asked if more information should be available about CAC members. David shared maybe a short video about each CAC member.
- o Randy shared important to understand CAC members are individuals and not all people with same disability are the same.
- Need to learn about work at CDCI.
- o Lindsey recommended a resource guide about community partners.
- o Attend some self-advocacy meetings around the state.
- o Need information on history of the disability rights movement.

#### **Goal 5: Maintain CDCI**

- o Jesse gave a short review self-advocates, DEI
- o What is most important?
- o What new priorities should we consider
  - Nicole shared that more self-advocates could be working with core function coordinators. Self-advocates could also work with different CFCs at different times.
- Randy said important for high school students to learn about selfadvocacy.
  - Valerie shared that BEST Project is working with Up for Learning which supports advocacy.
  - o Karen asked if dual enrollment is a possibility. Dual enrollment is when high school students are taking college classes.

- o Karen shared the evaluation work is important. Policy work needs to be grounded in data. Data can help make change.
- o Need more students taking classes to learn about disability and inclusion. Especially important at UVM because so many students are from out of state who may not have same lived experience as people in Vermont.
- David shared so many are not aware of history. And they need to understand that the fight goes on.
