Once you create your farm profile you can add or remove e-mails that you want to be on the vegetable and berry growers listserv. These can be updated at any time.

You can also write your produce safety plan and sign up for CAPS accreditation. And, you can upload and store your soil test by individual farm fields, as well as create or upload your soil amendment plans and records. This will help you comply with Required Agricultural Practices.

Annual membership in the VVBGA costs \$60 per farm, (or \$70 after Jan 31.) Farms from beyond Vermont pay \$36 (because of the high cost of the program).

If these fees pose a financial hardship it is easy to request a reduced rate on the web site. We want all vegetable and berry farms in Vermont to become members. We also have member farms growing many other crops such as ornamentals, hemp, and tree fruits.
